Subject: Activation of Online Portal for Paramedical employees in the Cadres of Physiotherapist, Occupational Therapist, Dental Hygienist, Dietician, Sr. Dietician, Medical Record Officer, STA (Radiology) & STA (ECG) in ESIC for Annual General Transfers – 'Transfer Year 2026' – Regarding,

Attention of all Paramedical employees in the cadres mentioned under subject above in Employees' State Insurance Corporation (ESIC) is drawn to the transfer/posting policy issued vide letter number Z-11/11/1/Misc/2021-Med.VI-Part(3) (\$779649) dated 28.12.2024. This policy outlines a portal-based online mechanism for submitting the order of preference by paramedical employees in the cadres mentioned under subject above, against the vacancies approved by the Competent Authority.

Online transfer requests (order of preference) received through the portal will be considered and decided by the Transfer Committee in accordance with the provisions prescribed in the transfer/posting policy dated 28.12.2024.

The online portal will remain active from <u>09.12.2026</u> to <u>13.12.2026</u> for all Paramedical employees in the said cadres to submit their transfer requests/options.

The Heads of the Office concerned must verify and forward the online requests in accordance with the provisions of the transfer policy by 5:00 PM on 15.12.2026 without fail to facilitate timely action by the Headquarters.

Further to inform all the concerned that as per transfer policy Clause 6a(c) "mere availability of vacancy at a particular place will not bestow any right of being posted against that vacancy, if such a move jeopardizes the continued availability of services in that specialty/ health facility; or any other functional ground."

In case of technical issues with the 'Transfer Module,' employees concerned should immediately contact the ICT Division in email: - jivnath.jha@esic.gov.in using their official email, attach a screenshot of the issue, and request resolution within the portal's activation. The ICT Division at Headquarters will ensure timely resolution of these issues so that employees can submit their requests within the stipulated timeframe.
