CIRCULAR

Sub: Revised Bond conditions in r/o of Post Graduate students - reg.

It has been brought to the notice of all the Post Graduate students (i.e., all existing PG students, Fresh PG Pass-outs, PG pass-outs who are already serving as SR under ESIC Bond) that Hqrs' Office vide memorandum No.L-11/12/3/2018/Corp.Cell/MEC(PF) dated:28.07.2020 has revised the PG Bond conditions as detailed below:-

- 1. <u>In case of Pass-outs already serving under Bond</u>:- If the length of service is rendered in excess of 02 years, they may be relieved without payment to ESIC for left over Bond period.
- 2. <u>Fresh PG pass-outs (Current year):-</u> would have to submit Bank Guarantee for the total Bond amount (as revised) upfront if they opt to serve the Corporation. In event of not opting to serve, they would have the option to pay revised Bond amount and be relieved.
- 3. <u>The existing PG students:</u> would have to execute fresh bond with revised conditions along with submission of Bank Guarantee, within three months of issue of these instructions.

<u>Post-Graduate trainees, who do not execute the revised bond afresh with</u> <u>submission of Bank Guarantee as applicable within 03 months, would be governed</u> <u>by their original Bond conditions.</u>

Therefore, All the students concerned (i.e., all existing PG students, Fresh PG Pass-outs, PG pass-outs who are already serving as SR under ESIC Bond) are hereby directed to follow the above instructions and execute fresh bonds with revised conditions & along with submission of Bank Guarantee(issued from any Nationalized Bank) to this Office within the stipulated time.

Further, it is also informed that the Original documents of the **student/trainee would be retained** by this Institute, till the submission of Bank Guarantee.
