## 1) Qualification and Experience:

DCI/ARPM/R/Gen/Gen/130/2023-24/2023/4424 dated 3/10/2023.
Dental Faculty	As per Dental Council of India BDS Regulations 2007

**\*Besides, the applicant be asked to strictly follow the provisions prescribed in DCI BDS/MDS course regulations, as amended from time to time.**

## 2) Age limit:

Medical Faculty	Not exceeding 67 years as on the last date for receipt of application forms
Dental Faculty	Not exceeding 62 years as on the last date for receipt of application forms

- 3) Consolidated remuneration as per ESIC Hqrs. Office Memorandum No. Z-17/11/1/2007/Med.IV (Pt. File) dated 13.04.2022 & Z-11012/51/2022-MED-VI dated 08.12.2022 as on date in different categories is as under or applicable from time to time as per ESIC policy:

Further, dearness allowance (DA) shall be payable on rates, so revised, from time to time. However, no payment towards arrear of DA shall be payable.

- 4) No other allowances will be paid in addition to the consolidate remuneration.
- 5) No Private practice is allowed during the tenure of service in ESIC.
- 6) Candidates with the eligibility of higher post (Professor/Associate Professor) would be permitted to be interviewed against the lower post (Associate Professor/Assistant Professor), and in event of selection, the candidate would be considered for placement with suitable up-gradation of the lower post as per eligibility and recommendation of the selection board. The up-gradation would be temporary and would be limited to the tenure of the teaching faculty/appointment of regular faculty in the lower post.
- 7) Retirees from Central/State Govt. /PSU from the equivalent posts are eligible to apply. In addition, persons working in recognized/approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.
- 8) The candidates have to attach self-attested copies of all the relevant certificates/testimonials for support of date of birth, category-sub-category, educational qualification, teaching experience, paper publications, etc. with the application form and have to produce originals thereof at the time of interview.
- 9) **The contract would be initially for a period of one year, further extendable on annual basis upon satisfactory performance and the candidate cannot claim for regularization on the post.**
- 10) The contractual engagement can be terminated by giving one month notice on either side.
- 11) The tenure of contract shall be one year or till joining of regular incumbent whichever is earlier.
- 12) Selected candidates will have to join immediately and not later than 15 days after receipt of the offer of appointment by Post/by hand.

#### **HOW TO APPLY:**

- 1) Candidate should report by 9:00 A.M. at the venue on the scheduled date of walk-in-interview.
- 2) Candidate should produce all original document in respect of all the parameters in the form at the time of verification on the day of walk-in-interview.
- 3) Please bring duly filled and signed application form in the prescribed format **(See Annexure-I)** along with the original set of all relevant certificates. One set of self-attested copies of all the original documents, two recent passport size photographs and the relevant certificates should be submitted at the time of verification on the day of walk-in-interview.

**Mode of Payment:** The Demand Draft should be with a validity of at least three months, in favor of “**ESI Account No. 1-Central**”, drawn on any scheduled bank payable at New Delhi.

**Note:**

- (ii) Only Demand Draft drawn on any Scheduled Bank will be accepted. Application Fees paid by any other mode will not be accepted.

6) The following certificates and testimonials should be attached to the application:

- (i) Proof of age (Secondary examination certificate for Date of Birth).
- (ii) Educational qualification (Graduate, Post Graduate Certificate, & any other).
- (iii) Medical Council of India/Dental Council of India recognized teaching experience issued by the Head of the Institute or Head of the Department.
- (iv) Valid MCI/DCI/State Medical Council Registration certificate.
- (v) Research paper, publications.
- (vi) Self-attested copy of Community/Status Certificate in updated Government of India prescribed Format, Sub-category, in case of candidates belonging to SC/ST/OBC category. Candidates claiming reservation/age relaxation on the grounds of belonging to OBC category should submit the valid community certificate prescribed vide Govt. of India, Department of Personnel and Training O.M. No. 36033/1/2013-Estt.(Res.) dated 13.09.2017 along with self-declaration, failing which the benefit of reservation and age relaxation will not be given. **(See Annexure II, III).**
- (vii) Certificate issued by the competent medical board in respect of Persons with Disabilities. **(See Annexure-IV).**

(viii) NOC if a candidate is employed in Govt. /Semi Govt. /Autonomous bodies etc., from the employer.

### **General Conditions:**

- (a) Crucial date for determining the age limit and other eligibility criteria shall be **27.11.2024.**
- (b) Mere submission of an application does not confer any right upon the candidate for being called for the interview.
- (c) The verification of documents will be done on the scheduled date of the walk-in-interview.
- (d) The application and the other documents should be arranged in the above-mentioned order, one below the other. Applicants need to carry original documents for verification at the time of the walk-in-interview.
- (e) If any candidate wishes to apply for more than one post, he/she must apply with separate sets of application forms, documents and testimonials, photographs, and separate demand draft fees for each post applied for.
- (f) Incomplete or unsigned applications or applications received after the due date of receipt of applications will summarily be rejected without any communication to the candidate.
- (g) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage. The opportunity of the interview given to candidates will be on a provisional basis.
- (h) Before applying for the post, the candidate should ensure that he/she fulfills the eligibility criteria mentioned above on the crucial date for all purposes. The ESIC Dental College would be free to reject any application at any stage of the selection process if the candidate is found ineligible for the post for which he/she has applied.
- (i) Canvassing in any form will be a disqualification.
- (j) Disqualification – No person :-
  - I. who has entered into or contracted a marriage with a person having a spouse living; OR
  - II. who, having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said posts.
  - III. Provided that the Competent Authority may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Regulation.
- (k) No TA/DA is admissible for attending the walk-in-interview.

### **Selection Procedure:**

- (i) Selection of candidates will be made on the basis of the walk-in-interview conducted by the ESIC Selection Board.
- (ii) The minimum qualifying marks during the walk-in-interview shall be as under:
  - UR category – 50%
  - SC/ST/PWD candidates – 40%
  - OBC category– 45%
- (iii) The result of the walk-in-interview shall be published and uploaded on the website and no inquiry or correspondence in this regard will be entertained.

- (iv) In case the selected candidate does not join, the next candidate in the panel will be offered the appointment.

**NOTE: In case of any change or modification in the said matter/notification or any subsequent change in the schedule of the interview, the same shall be uploaded on the website Candidates are requested to check the website regularly.**
