#### Terms and condition:-

- (a) In case of Full Time/Part Time Super Specialist, the engagement will be for a minimum period of **three years** or till joining of regular incumbent or attaining 70 years or age, whichever is earlier. The contract would be extendable yearly based on satisfactory performance.
- (b) The Full time Super Specialist should be available on call 24X7. The Part time Super Specialist should be available 24 X 7 if they submit their willingness for emergency visit.
- (c) The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.
